It was resolved to accept the minutes of the last meeting as a true record, and it was signed by the Chairman.

3. To receive updates from County and District Councillors

Please find the full report from County Councillor Kiddle-Morris on the website. National highways are in the process of reviewing the planning applications to make the A47 a dual-carriageway. The applications were overturned and this will go to appeal to the High Court. However, if this doesn't go to appeal the Tuddenham to Easton works will hopefully commence later this year. Devolution debate is still going on and voting will not take place until December. The Local Plan will be looked at again in November and up to 2000 sites called will be reviewed. A consultation will last approx. 8 weeks and the aim is for this to be released in November 2024.

4. To report progress on items not on the agenda from the last meeting

5.1 Modification application for the addition of restricted byway

No current update, so this item will be removed from the agenda.

5. Open Forum for Public Participation

A parishioner raised concerns about Dodman's Lane after a long discussion it was established that this has been repaired many times but will need a complete rebuild. The Council currently doesn't have any plans or finances for this to happen immediately.

6. To report and update on highway matters

The Clerk had reported the block ditch opposite the holiday lets to highways as this was getting blocked after the corkscrew had been used for the gullies. Highways had acknowledged that the work had been carried out but the Council can't see any improvement. Highways also confirmed that the street signs have been cleaned, but the main signs are still dirty. The Clerk will report both items again. The speed restriction on the B1146 will be looked at in September from highways and the village sign is still waiting to be re-located.

7. To discuss the new contractor for the Churchyard grass cutting

The Council agreed to continue with the present monthly cuts up until September and a possible extra cut if needed in October. The Clerk will inform the contractor.
