Meeting Minutes of Horningtoft Parish Council Wednesday 9th November 2022 at 19.30 held at St Edmunds Church

Parish Councillors present: Andrew Hill (Chairman), Pauline Chapman and Tracey Hawke Also present: Donna Secker (Parish Clerk), 2 members of the public and District Councillor Hambidge.

1. To receive apologies for absence

Councillor Drew and County Councillor Kiddle-Morris sent their apologies, and these were accepted. Councillor Baker was not present.

2. To receive declarations of interest in items on the agenda

No Declarations of interest were declared.

3. To approve the minutes of the meeting held on 13th July 2022

It was resolved to accept the minutes of the last meeting as a true record, and it was signed by the Chairman.

4. To receive updates from County and District Councillors

District Cllr Hambidge updated the council with the approval of the Dairy Farm at Wellingham.

5. To report progress on items not on the agenda from the last meeting

The village map is still being completed.

6. Open Forum for Public Participation

A parishioner requested for more dog bins to be installed. The clerk will contact Breckland to request land where the bins can be located. The bins will be a cost to the parish of approx. £150

A parishioner thanked the council for organising the Defibrillator awareness training that was held on Wednesday 2nd November. This was well attended with 16 parishioners completing the training. The parishioner reported that more residents would have attended if they had known about it. The training was advertised on two websites and a notice was put on the notice board. The council had a discussion to see how this could be overcome and was agreed to see if the clerk is able to obtain some leaflets and deliver these to the houses.

7. To report and update on highway matters

The clerk updated the council that the rangers cleaned the signs (unfortunately only in one area of Horningtoft).

The drain opposite the church is causing flooding to the road due to the drain being higher than the road. The drain on the Brisley Road junction is also blocked.

The council had a long discussion about the request to reduce the speed limit to 40mph on the B1146 within the Horningtoft perimeter. The clerk will action this request.
