# Meeting Minutes of Horningtoft Parish Council Wednesday 29<sup>th</sup> November at 7.30pm at St Edmunds Church, Horningtoft

Cllr Hill welcomed everyone to the meeting and thanked everyone for attending.

#### 1. To consider accepting apologies for absence

Cllr Hibberd sent his apologies and these were accepted. County Cllr Kiddle-Morris sent his apologies.

# 2. To approve the minutes of the meeting held on 13th September 2023

It was resolved to accept the minutes of the last meeting as a true record, and it was signed by the Chairman.

#### 3. To receive any brief updates from County and District Councillor

County Councillor Kiddle-Morris's report can be found on the website. District Cllr has again made no attempt to attend the meeting and has no made communication with the Clerk.

## 4. Open forum for Public Participation: an opportunity to hear from members of the public

A parishioner reported that flooding is still occurring outside the Church, this is due to the manhole cover being higher than the road and therefore the water can not drain away. This has been reported previously but the clerk will report this again.

#### 5. To report and update on highways

Due to the recent heavy rainfall, flooding occurred on the B1146 and nearby houses were so close to being flooded.

The Council are still requesting and urgently supporting with the backing of County Cllr Kiddle-Morris for the speed limit on the B1146 to be reduced and with the recent flooding the speed of traffic going past the houses, their banks and verges are rapidly eroding.

The Clerk updated the Council regarding the moving of the village sign, Cllr Kiddle-Morris is still looking into highways moving the sign or cutting back the verge.

Cllr Drew reported a potential water leak on Oxwick Road. A level marker has been placed within the ditch to establish the water levels which can be recorded as evidence to report to highways.

## 6. To update the Council on the recommendations of email address to gov.uk

It has been recommended that the Parish Council move over to a gov. uk email address and website. The cost of this would be £180 per year. The Council will review this in a year when this may become mandatory. All Councillors agreed to make a specific email address for Council business.

#### 8.1 An update from the PCC regarding the repairs to the Church

A statement was forwarded to the Council before the meeting for the review. Cllr Hill requested for this item to be moved to the next agenda.

Cllr Hill thanked Cllr Chapman for organising the new bank mandate forms to be completed by the Council. The Council agreed to the list of payments for September 2023.

# 9.2 To discuss and approve the Budgets and precept for 2024/25

It was agreed that the new precept will be increased by £250 making the yearly precept £2200. This was unanimously agreed by the Councillors.

#### 9.3 To Discuss the option of changing banks

The Clerk informed the Council that it is becoming increasing hard to communicate with the current bank Barclays and the problems are increasing. The Council agreed to complete the mandate forms one last time with the hope that Barclays process the forms.

## 9.4 To discuss and approve the cost of living rise for the clerk's salary

The Council agreed to back pay the clerk's salary from the 1st April 2023.

The next meeting was confirmed to be on Wednesday 31<sup>st</sup> January 2024. Item for next agenda, change of use of dwelling.
